COL Dennis M. Moen, Ph.D., P.E.

Dennis M. Moen is a graduate of the United States



Military Academy with a BS degree in civil engineering. He received his M.S. degree in electrical engineering from the University of Arizona and his Ph.D. in Information Technology from George Mason University. He is a licensed Professional Engineer (P.E.), a Senior Member of the Institute of Electrical and Electronics Engineers (IEEE), a Life Member of the Armed Forces Communications and Electronics Association (AFCEA), a Life member of the VFW and MOAA.

Denny served 26 years in the Army with tours with the 173rd Airborne Infantry Brigade in Vietnam, Company Commander with the 26th Signal Battalion in Heilbronn, Germany, and Battalion Commander of the V US Corps signal battalion (17th Signal) in Frankfurt, Germany.

In 1987, Denny was nominated by the Army and accepted by the National Aeronautical Space Administration (NASA) for a Space Science Fellowship Program. He served on a team to begin the planning for space science programs for the Space Station. He also prepared a program plan for the development of a space science experiment called Gravity Probe-B, the first ever science experiment to demonstrate Einstein's theory of relativity. He also authored a study directed by President Reagan that identified all US space launch requirements for the following 15 years. During his final 10 years in the army, he served in numerous leadership positions to develop high-speed networking across the Department of Defense.

After serving in the US Army, retiring as a Colonel, he worked with two start-up companies, the first being Network Solutions, the original administrators of the .com, .edu, .org, and .mil Internet domains. In his second experience at a start-up company, he was the Technical Director and the project manager for Primus Telecommunications International where he successful led the development and deployment of a global network offering the first Voice over Internet Protocol (VoIP) service for international calling. He also worked as a research engineer principal at Lockheed Martin corporation overseeing research in advanced wireless sensor networks and new adaptive Internet protocols.

In 2006, he started his own professional engineering services company providing consulting and research services to industry and government agencies. Today this family business is run by his son.

He has published numerous technical papers on new Internet protocols, communications systems and new concepts for healthcare information systems. He has also made technical contributions to the Health Insurance Portability and Accountability Act (HIPAA), the IEEE Health Care Informatics Standards, and the International Simulation Interoperability Standards Organization (SISO). As a lifelong volunteer of the IEEE, he has served as Chair and Treasurer of the local CSRA Section of the IEEE.

Denny currently is retired, though continues to provide advice to another start-up company developing visible light communications capabilities as a replacement for WiFi in specialized applications. He is a volunteer helping AFCEA with their annual weeklong National/International Cyber Conference held at the Augusta Convention Center. Four years ago, He was instrumental in starting a math tutoring program at the Hope Center in Graniteville which he continues to lead today, helping young people improve their scores on the Military AVSAB entry exam. The AVSAB program continues to grow working with the local recruiters for all military services enabling many young people that want to serve our Country become eligible by meeting the services entry requirements. He lives in Aiken, SC with his wife of 54+ years, Nancy. They have two children and 4 grandchildren.



Surviving Spouse Corner

What to Know About National Cemetery Burials

Service members and veterans, and their spouses, are eligible for burial at national cemeteries. Also eligible are minor dependent children and, under certain conditions, unmarried adult children with disabilities. An eligible spouse and children may be buried in a national cemetery even if they predecease the veteran.

If you or a loved one are considering burial in a national cemetery, here are three helpful considerations:

Locate the nearest cemetery. The VA operates 156 national cemeteries in 42 states and Puerto Rico. However, not every state has a VA cemetery. To find a cemetery close to you, visit https://gravelocator.cem.va.gov.

[MOAA PUBLICATION: Your Guide to Military Burials]

Plan ahead. Make an emotional and stressful time less difficult by completing arrangements in advance. Learn more about the pre-need eligibility determination process, and fill out forms online, at this link. Other needed documents, such as a DD Form 214 or other separation documents, can be requested online.

Know your resources. Don't underestimate what the VA can do for you. You can learn more about VA burial benefits from local VA national cemetery offices, the National Cemetery Administration, and VA regional offices, toll-free at (800) 827-1000.

MOAA's publication Preparing for the Loss of a Military Spouse can provide further helpful guidance for getting your affairs in order. Premium and Life members can download the publication here.

Reminder from MOAA National



Reminders from national MOAA to remain non-partisan in everything concerning MOAA

Partisan Political Activities: As organizations exempt from federal taxation under Sec. 501(c)(19) of the Internal Revenue Code, MOAA and its affiliates must take care to avoid engaging in partisan political activities. Under IRS rules, we are prohibited from directly or indirectly participating in, or intervening in, any political campaign on behalf of (or in opposition to) any candidate for public office.

Divisive Social Issues: We are all aware of the divisive nature of the debate over today's leading social issues – protesting during the national anthem at sporting events, racial justice, public protests, and the conduct of law enforcement officers. These are issues over which many Americans have deeply held, but differing, personal beliefs. This is also true within the military community among the ranks of active duty and retired officers and within MOAA itself.

MOAA leaders have an obligation to keep this in mind when communicating on behalf of MOAA or its affiliates. Suggesting that MOAA only supports one side of a deeply divisive issue sends a message to those with a different belief that MOAA is not for them.
